

**MINUTES OF THE MEETING ON 28<sup>th</sup> JULY 2010  
at TARLAND PRIMARY SCHOOL**

**PRESENT:** Councillor Peter Argyle, Simon Welfare (Chairman), Sue Erskine, Evelyn Smith, Archie Leith, Sgt. Stuart Clark, Nigel Healey plus 3 members of the public.

**1. Tarland Report**

- 1.1 Traffic Calming:** Cllr. Argyle presented an email from the Roads department which stated that the Traffic Management scheme had 'fizzled out' and; although it was in process of being restarted, they could not give any date by which time it and the speed limit assessment were likely to be completed.

The meeting expressed disappointment over a number of assurances about traffic calming in the Tarland area which Aberdeenshire Council had been made over the past four years, none of which had come to fruition. In particular, there was concern about the roads around the Aberdeen Arms, where the combination of a blind approach and a narrow footpath presented a particular hazard.

(Subsequently, an article in the local press indicated that the Aberdeen Arms corner roadway was to be painted out to encourage drivers to take a wider line around it but this has not been confirmed to the CCC)

- 1.2 Damage to Bridge Wall:** No progress. It was suggested that the CCC should write to the Church authorities about ownership. If no agreement is forthcoming, then Aberdeenshire Council may be able to repair the wall and then recharge the cost to the Church.
- 1.3 Recycling Car Park:** Cllr. Argyle is to chase up a response to the request to provide some sort of permanent structure to retain road salt in the Recycling Area car park.
- 1.4 Waste Bin:** The Alastrean Woods waste bin has been delivered and is located at the Aberdeen Road end of the Kirk car park.. It has already been well patronised by responsible dog owners.
- 1.5 Footpath to the Knappieround Car Park:** No further progress.
- 1.6 Dog Fouling:** Awaiting confirmation that a general purpose waste bin will be installed in the Tomnaverie car park.

**1.7 Local Flooding:** Further heavy rain has resulted in repeated flooding of properties on Aberdeen Road and the conversion of the Cromar Cottages road into a lake. Whilst the Cromar Cottages problem has been long standing (and may be the responsibility of Scottish Water), the Aberdeen Road problems have only developed over the last couple of years.

In addition, the track at the entrance to 'Crossfield' is flooding; it is believed that the pipe beneath the track may be blocked. Cllr Argyle to alert the Roads department to the problem.

**1.8 Extension to St Moluag's kirk yard:** Simon Welfare has had a conversation with the official in charge at Aberdeenshire Council. As he is newly in post, he has requested time to investigate and report back.

Given the strong local opposition to the plan, it is interesting that the Local Development Plan identified the Glebe land as the site for the extension.

**1.9 Tarland Square Road Surface:** Tarland Square has become pot holed in areas
